

#### **The International Student Program**

- Canada's International Student Program has seen a decade of significant growth.
- The number of international students in Canada has doubled since 2004 to over 415,000 in 2016.
- The Government of Canada's International Education Strategy is designed to drive growth even further over the next decade.

Study Permit and Extensions Issued by Year, 2007-2016





# International Student Trends (continued)

- Growth in numbers of study permit applications across all levels of study in 2017 (January to November):
- **Primary/Secondary (K-12)**: 41,916 SP applications-an increase of 8.4% from 2016
- ESL/FSL: 30,702 SP applications an increase of 24.8% from 2016
- **College**: 80,431 SP applications -an increase of 29.7% from 2016
- University: 73,235 SP applications an increase of 6.7% from 2016

International Student application destinations are concentrated in 3 provinces: Ontario (46%), British Columbia (22%), Quebec (12%), Prairie provinces combined (11%), and Atlantic provinces combined (5%).

**Top 5 Countries of international student origin in Canada include:** China (27%), India (25%), Korea (6%), France (4%), and Brazil (3%). New Study Permit Applications Processed by Top Levels of Study 2014-2017



### **Study Permit Application Approval Rates**

- IRCC approved 75% (66% new permits, 94% extensions) of all study permit applications processed between January and November 2017.
- Approval rates vary across education sectors and fluctuate over the years:

#### **Overview of Requirements**

- IRCC issues study permits to applicants, if following an examination, it is established that:
  - they have been accepted to undertake a program of study at a DLI;
  - they applied in accordance with Immigration and Refugee Protection Regulations; and
  - they will leave Canada by the end of the period authorized for their stay.

#### **Overview of Requirements**

- Letter of acceptance from a designated learning institution;
- Purpose of visit;
- Duration of stay;
- Ties to Canada or country of residence;
- Previous international travel;
- Travel documents;
- Financial support;
- Criminal and health checks;
- Previous refusals and removals.

#### **Common grounds for refusals abroad:**

- Lack of or insufficient proof of adequate funds to support oneself while in Canada
- Not satisfying the visa officer that the individual will leave Canada at the end of their period of authorized stay
- Submission of fraudulent documents (e.g., letter of acceptance, diplomas, proof of funds, language test results).

#### Common grounds for refusals abroad based on *bona fides*:

Refusals based on *bona fides* are reflected in a number of refusal reasons. Some of the most common are:

- Purpose of visit
- Personal financial status
- Family ties
- Travel history
- Current employment situation
- Proposed length of stay

#### **Clarifying the concept of** *Dual Intent***:**

- **Dual intent** is when a foreign national who has applied for permanent residence in Canada also applies to enter Canada for a temporary period as a visitor, worker or student.
- An intention by a foreign national to become a permanent resident does not impede them from becoming a temporary resident. However, the officer must be satisfied that they will leave Canada by the end of the period authorized for their stay, if their permanent residence application is not approved.


#### **China: Processing Volumes and Approval Rates**

- In 2016, a total of 82,199 Chinese citizens were issued study permits (both new permits and renewed permits). This is a 16% increase over 2015, when 70,986 study permits were issued or renewed.
- With another 72,706 issuances and renewals between January and the end of September 2017, Canada continues to be a popular destination for Chinese international students.
- The total number of study permit issuances and renewals more than tripled in the ten years between 2006 and 2016.
- The overall approval rate for student applications received at mainland China offices in throughout 2016 and the first nine months of 2017 was 88%.

## China: ESL/FSL

- 61% increase in new ESL/FSL study permit applications, from 3,867 in 2016 to 6,549 in 2017
- 80% approval rate for new ESL/FSL permits in 2017, an increase from 77% in 2016





# China: Study Permit Refusals and Findings Common grounds for refusal in China:

- Insufficient funds
  - In the Study Direct Stream and the Student Partners Program, students will have to obtain a GIC (guaranteed investment certificate). This document is useful for the officer when reviewing an application.
- Fraudulent bank documents
- Fraudulent letter of acceptance (LOA)

#### **Mexico: Processing Volumes and Approval Rates**

- The number of study permit applications processed in Mexico City has remained relatively constant in recent years, between 5000 and 5500
- As of October 2016, the make-up of the caseload has changed as Mexico City has become a regional processing hub, now processing applications from:
  - Mexico
  - Venezuela
  - Central America
  - Haiti
- The Mexico City refusal rate has fluctuated as the composition of the caseload has changed, with a marked increase from 2016 to 2017


## **Mexico: ESL/FSL**

- Number of applications for new ESL/FSL permits relatively stable
- Fluctuation in approval rates for all study permits due to change in make-up of caseload of Mexico City case processing centre
- 92% approval rate for new ESL/FSL applications in both 2016 and 2017 (January to November)
- Concerns regarding bona fides and insufficient financial resources most commonly cited refusal grounds

#### **Brazil: Study Permit Refusals and Findings**



- ESL/FSL makes up a large portion of the case load
- Around 8,800 study permit applications received in 2017
- Around 1,600 were ESL/FSL study permits

#### **Brazil: Study Permit Refusals and Findings**

- Slight decrease in new ESL/FSL study permit applications (1,492 in 2017, from 1,634 in 2016)
- Approval rate for ESL/FSL study permits remains relatively stable, 72% in 2017 compared to 74% in 2016
